## I. Residency & Registration

### Are you a...

- Resident of Santa Barbara County?
- Registered Voter in Santa Barbara County?

- Voted in at least 1 of the last 3 Statewide Elections?  
*(3/3/20, 11/6/18 or 6/5/18)*
- Been registered with the same political party for the last five years?

## II. Financial Interests, Investments & Influence

### **Within the last 8 years, No Applicant May Have Had...**

- Any “significant financial interest” with a company, corporation or business entity that has donated \$500 or more in one year to any candidate for elective office in Santa Barbara County
- Any “significant financial interest” with a company, corporation or other business entity that has donated \$500 or more in one year to Candidate Controlled, Primarily Formed, General Purpose or Independent Expenditure Committee that expended funds in support of/opposition to a Santa Barbara County Candidate

### **Within the last 8 Years, No Applicant or Immediate Family Member May Have...**

- Contributed \$500 or more in one year to a Candidate Controlled, Primarily Formed, General Purpose or Independent Expenditure Committee that has expended more than \$1,000 in support of/opposition to a candidate for elective office in Santa Barbara County
- Been a Board Member, Officer, Paid or Volunteer Staff of, or had significant influence on the actions/decisions of a political committee required to register with the California Secretary of State and expended more than \$500 in support of/opposition to a candidate for elective office in Santa Barbara County; this includes member communication

# Measure G2018

## Regulations & Terms Defined

### Regulations & Terms Defined

#### **a. Significant Financial Interest**

- Ownership or partial ownership, other than through the not more than 5% of the stock of any corporation that is allowed through supporting criteria, of any for-profit company, corporation or other business entity with gross receipts of over \$100,000 derived from doing business in Santa Barbara County in any of the last five calendar years prior to appointment
- A partnership interest in any for-profit company or business with gross receipts of over \$100,000 derived from doing business in Santa Barbara County in any of the last five calendar years prior to appointment
- Holding the position of Director, CEO or Manager with a salary in excess of \$100,000 per year in any for-profit company, corporation or other business entity doing business in Santa Barbara County
- Ownership of more than 5% of the stock of any corporation or business entity doing business in Santa Barbara County
- Being an immediate family member of any person described in the preceding four sections

#### **b. Board**

- The Santa Barbara County Board of Supervisors

#### **c. Commission**

- The Santa Barbara County Citizens' Independent Redistricting Commission

#### **d. Immediate Family Member**

- Spouse, Child, In-Law, Parent or Sibling
